**The permit expires at midnight on the date for which it has been purchased.**

- Exclusively for buses going to accommodation facilities, the pass expires at 12:00 of the day following the day of validity, or in any case until 12:00 of the day following that of the last permit, in case of multi-day purchase.
- Minibuses with up to a maximum of 16 seats (plus 1 driver) are exempt from paying the pass.

## **1. Ordinary tourist bus**

For buses with a **motor Euro 6**, it is always necessary to exhibit the vehicle registration document.

## **2. Tourist Bus used for school trips**

A lowest price is granted for the tourist buses conveying students (**under 18 years**), attending the public school and colleges: primary and grammar schools, secondary schools, vocational schools, technical and commerce schools. **Students of any University will be considered like ordinary tourist.**

The group manager must provide (or attach to the online request) a **letter of presentation and confirm** from the school management, on the school's letterhead with the school manager's stamp and signature. Handwritten or incomplete documents will not be accepted.

In the absence of such documentation, the maximum ordinary rate will be applied.

## **3. Atypical service under Regional Law 46/1994**

Buses authorized for atypical service under Regional Law no. 46/1994, or the authorized trade service (intercommunal/interregional/international), excluding buses carrying workers or connecting shopping centers.

## **4. Tourist buses driving to the hotel/campsite in the Municipality of Cavallino Treporti**

The price is applied to tourist buses that transport groups staying in the accommodation facilities of the municipalities of Cavallino-Treporti and Jesolo: buyers must demonstrate the overnight stay by submitting a booking voucher, to be presented at the office, or to be attached to the online request (made on the site [www.ctservizi.eu](http://www.ctservizi.eu)).

To purchase passes **ON LINE**, you must register your credit card on the 3D Secure circuit.

You are also asked to send an email to the ZTL office, attaching a copy of the bus registration document of the vehicle you intend to use: only after confirmation of the license plate number in our database, it will be possible to proceed with the online-purchase.

We recommend that you consult the page <https://ctservizi.eu/it/ztl-bus>, in the website [www.ctservizi.eu](http://www.ctservizi.eu), to register your business Company.

There is a flat rate of € 360,00 for the purchase of a number greater than four (4) permits, to be used in subsequent days, without interruption, and exclusively for the same bus.

If the purchase is made **AT THE CAVALLINO-TREPORTI OFFICE** for a number of passes equal to or greater than 4, to be used on several successive and continuous days, the flat rate of € 400,00 is applied.

It is possible to appoint the staff of the accommodation facility in question to purchase the permits, provided they have the necessary data requested.

**Without the request documentation, the office applies the maximum tariff for ordinary bus.**

## **5. Exempt buses**

Exemptions are authorized exclusively by the C.T. headquarters. Services. Anyhow they must be requested and granted in advance, providing adequate documentation.
